## **October Program Summary**

Kathleen H. Waters, MCD, CCC-SLP, Speech-Language Pathologist at Memorial University Medical Center, discussed dysphagia (swallowing disorder) and vocal weakness in polio survivors. With an anatomical drawing she described all the body parts and the process involved in a normal swallow, which occurs within less than a second and is very complex. She discussed how it can deviate in individuals for various reasons. Ms. Waters explained the evaluation of patients with suspected swallowing disorders. For swallowing difficulty she advised taking smaller bites of food, chewing thoroughly, using a head turn or chin tuck during a swallow, and increasing texture of liquids if needed. When taking pills, it is advisable to take a drink of water first. If taking multiple pills, group them by size and then swallow. Do not tip your head back, but keep your chin down. Swallowing a canned peach slice along with the meds assists some people. Eat food and swallow pills in an upright position. If in the hospital, insist on this position even if the staff does not. from notes of M. Dunnermann

David is the president and owner of Positive Image Prosthetics and Orthotics in Savannah, Georgia. He founded PIPO Missions, Inc./Medical Outreach in 1999 and has made over 100 mission trips to Mexico and Columbia, providing no-charge artificial limb and orthopedic brace care clinics. David was in the news internationally in 2008 and 2009. He received a 2008 CNN Heroes Award in recognition of his philanthropic work in Mexico and Columbia, along with nine other recipients from a field of 7000 nominees. David was awarded the Ellis Island NECO Award in 2009 for his international philanthropic work, one of 98 recipients in the world.
